In the beautiful setting of the academy in Brescia, the sixth edition of the Talent Summer Courses will take place.

Students will have valuable opportunities to study with renewed teachers and play in public recitals or as Soloist with Orchestra in 60 concerts organized during the courses.

Harp class is held by Floraleda Sacchi, acclaimed International soloist, recording artist and passionate teacher who studied with Judy Loman, Alice Giles and Judith Liber among others. [www.floraledasacchi.com](http://www.floraledasacchi.com)

### **RULES AND APPLICATION FORM**

By sending the registration form the participant agrees with the general conditions and abides by them.

#### **1. REGISTRATION AND APPLICATION DEADLINES**

Registration is possible online.

The registration form available at <https://goo.gl/forms/Jyp8oEY8kNm6Gxkl1> has to be fully completed. Registration of a participant who is under age has to be made by the parent or legal guardian. Registrations by post or fax will not be accepted and not taken into consideration.

**APPLICATION DEADLINES:**

30th of June 2023

#### **2. CONDITIONS OF PARTICIPATION**

In principle there is no age limit to participation in the master-classes. Practice facilities will be provided for all participants and the academy guarantee a daily number of two practicing hours to each participant.

If by the closing date of registration a master-class or course with the chosen professor does not have the minimum number of participants the registration and participation fees will be refunded. The academy reserves the right to reduce the number of days on which the master-class or course is held. Nevertheless, even if this is the case, all participants receive the full number of teaching units.

#### **3. NUMBER OF LESSONS, PARTICIPATION AND REGISTRATION FEE**

Each student or ensemble will receive 4 lessons

Soloist:

Active Students: 570 Euro (including 100 Euro of registration fee and piano accompaniment) for Talent Summer Courses

Active students regularly enrolled can ask for extra lessons. In this case the fee is 150,00 Euro per hour.

Duo:

Active: 750 Euro (including 200 Euro registration fee for two persons)

Trio:

Active: 950 Euro (including 300 Euro registration fee for three persons)

Ensembles:

Active: 1150 Euro (including 400 Euro of registration fee for the entire ensemble)

#### 4. CONDITIONS OF PAYMENT

The registration fee has to be paid immediately and the payment receipt must be sent by email with the registration form. All expenses and fees for international transfers are to be paid by the participant and will not be covered by the academy. The participation fee can be payed by bank transfer before the beginning of the course or by cash the first day of the course.

Any exchange expenses or bank commissions will be charged in full to the student.

#### 5. WITHDRAWAL

In case of written notification of withdrawal, the registration fees will be retained; the remaining amount (participation fee) will be reimbursed. All transaction charges will be deducted. If you withdraw, it is essential to state your international bank account details (including the Bank Identification Code BIC and the International Bank Account Number IBAN/PayPal-account) as well as the address of your bank.

If withdrawal occurs after the application deadline, the participation fee will not be reimbursed and must be payed.

The full participation and registration fees will be reimbursed if the academy is forced to cancel a master-class or course.

Reimbursements can only be made until 31 October 2023.

#### 6. CONCURRENT ATTENDANCE OF SEVERAL MASTER-CLASSES

It is possible to attend several master-classes which have to be paid for according to the tariffs stated.

#### 7. CHANGING TO A DIFFERENT MASTER-CLASS OR DIFFERENT COURSE

Once the master-class or course booked has started, it is not possible to change to a different one unless the participant pays the full participation fee for both master-classes.

#### 8. CERTIFICATE

The successful completion of a master-class at the Talent Music Summer Courses & Festival held by internationally renowned artists can be an important asset in every artist's

biography. At the end of their master-class, active participants receive a diploma confirming their participation.

#### 9. LIABILITY

Participation in the Talent Music Summer Courses & Festival occurs at the participant's own risk. Participants are responsible for damage which they may cause. Liability for compensation, in so far as it is not based on intent or gross negligence is out of the question, in particular if a master-class or a course has to be cancelled.

If the masterclass cannot take place in live due to force majeure, the Organization reserve the right to organize all the lessons online. The organization will guarantee to all the musicians attending Talent Summer Courses and Talent Summer Opera & Festival the performance as Soloist or Soloist&Orchestra in live concerts by arranging a concert season in a different period and inviting all the musicians to perform in live. In this case, the auditions to perform as Soloist&Orchestra will be organized by sending a video-audio recording of the own performance to the organization.

#### 10. SPECIAL CONDITIONS FOR PARTICIPANTS WHO ARE UNDER AGE

The parent or legal guardian who concludes the contract for participation in the Talent Summer Courses and Talent Summer Opera & Festival on behalf of the participant who is under age, declares his or her agreement with the fact that the academy cannot assume any responsibility for supervising the participant who is under age. This applies in particular to behavior immediately before the beginning of the master-class/course or at the end of the master-class/course and outside the rooms where the master-class/course is held. Every registration of a participant who is under age requires a signed declaration by the parent or legal guardian to this effect.

The parent or legal guardian is responsible for damage caused by the participant who is under age. Furthermore, the parent or legal guardian indemnifies the academy concerning all claims to compensation which are asserted by the participant who is under age.

#### 11. CHOICE OF LAW AND PLACE OF JURISDICTION

It is agreed that Italian law applies for all conflicts resulting from or related to the business relationship under exclusion of norms of international private law and of the UN Convention on Contracts for the international sale of goods. The place of jurisdiction for all conflicts resulting from or related to the business relationship is Verona, Italy.
